Introduction

The Manor

The mediaeval manor was a landed estate that involved rights and obligations. The term 'manor' was introduced throughout England in the late 11th century and applied to estates differing widely in size and structure. Some were scarcely larger than the property of a prosperous peasant. Others covered numerous villages and contained within their boundaries estates large enough themselves to be considered subordinate manors. In Staffordshire, the parish church and manor house nestling together, symbolising lay and ecclesiastical authority over a similar area, did exist but was far from common.

The accumulations of land and rights to which the term 'manor' was applied differed widely and could include the opportunistic or optimistic. The opportunistic man holding land in a large manor belonging to someone else learns that advances in technology may make workable mineral resources below his land. By inventing 'his manor', he hopes that his title to the minerals lying under the land may be established. At the optimistic end of the spectrum are those 'manors' which appear solely in property lists and the title deeds and settlements of large landowners. They are the creation of imaginative conveyancers, anxious to protect any rights which they feel their clients might have in land, although it is outside any boundaries of any manors they may hold. These 'manors' never produced a document, unlike the opportunistic manors previously mentioned.

The Documents

Manorial documents were produced in the administration of manors and began to appear during the 12th century; by the late 13th century they were not uncommon and by the end of the next century they were commonplace. Manorial administration produced three main groups of documents:

1. Surveys of one kind or another, which give a picture of a manor, or some aspect of it, at a particular moment
2. The manor court roll and its satellites, which record transfer of land between tenant and lord and tenant and tenant, as well as the day-to-day transactions between them
3. Accounts of varying kind, arising from the financial interests of the lord in his manor, including the names and rents owed by tenants

Surveys

Physically these can vary from the elaborate library-bound volumes to single sheets of paper, and, of course, from 1600 or so onwards information in a manorial survey may be the written 'back-up' to that given on a map. Surveys are the earliest known surviving manorial records and they continue in one form or another until the demise of manors as an administrative unit. Some are mere rentals, giving the names and rents owed by tenants (not recording those paid or

unpaid in any given year); others contain a wide variety of information. Payments, additional to rent, may be listed with a periodic payment like *pannage* (the right to pasture pigs) or casual payments such as *heriots* (death duties). Where appropriate the villein status of land and/or tenant is carefully noted but the need to identify the legal status of land persisted long after the disappearance of villeinage.

The amount of topographical detail included can vary from occasional field or spot names to a detailed description of anything between the property of one tenant and the whole village. From the 12th to 15th centuries in particular, in addition to any information relating to any tenant properties, surveys may include details of the land which the lord of the manor administered directly, called his demesne, in addition to the arable, meadow, pasture and waste, described in considerable detail. It lists other assets of the manor: fishponds, warrens, any mineral rights, such as coal, and any industrial activities such as metal works. In most of the above, whether it is land, labour services or mineral rights, the survey will frequently state its value in money terms. However, the user of these surveys must be aware that the compiler may have had reasons for including or excluding any one or more of the aspects of manorial organisation mentioned above.

Where a survey had been drawn up with one particular aspect of manorial administration in mind, they were sometimes given specific names. A *valor* is a document primarily drawn up to establish the value of a property. A *terrier* or *land-book* is a detailed, sometimes very detailed, topographical description of a property, whose complexity by itself shows why maps had to be invented. An *extent* is a term usually confined to a summary description of the demesne (land retained by the lord of the manor for his own use), the tenants' lands and the obligations of mediaeval manors. Not infrequently a major landowner would order a complete survey of his estate to be carried out and later all the extents were bound together in one document, as happened on the Bishop of Lichfield's estates in 1297/1298.

Manor Court Records

The engrossed formal manor court roll or manor court book is the final but not always the most interesting of a great variety of documents produced in the running of a manor court.

The manor court had three main concerns:

1. To record property transactions
2. To monitor and control, where appropriate, the agriculture routines within the manor
3. To record transactions and disputes between lord and tenant and tenant and tenant. A substantial number of manors had obtained, either by royal grant or by 'prescription', responsibilities for law and order jurisdiction, otherwise the responsibility of the Hundred Court (the lowest tier of royal administration in local government). This was called *view of frankpledge*.

The utility of the manor court records varies at different dates and in different places. 13th and 14th century entries on a whole variety of subjects tend to be

briefers and more cryptic than those in 15th and 16th century documents. On the other hand, for different reasons, the variety of business in many courts had decreased by the mid-15th century but this is not a universal trend. This is not just due to the date of the document concerned nor with whether the manor exercises *view of frankpledge*, but with the social and legal structure of the manor. It therefore depends on, for example, the number of villeins, the nature of the landscape (open or enclosed fields) and whether there were wastes, large rivers or mineral rights to be administered. The presence of large open fields will dictate the existence of entries relating to their management. Large amounts of pasture may influence the amount of information about villagers' livestock. Exceptionally, as with the Manor of Cannock and Rugeley, supervision of a private chase by the manor court will produce entries of a type associated with royal forest jurisdiction relating to deer and tree preservation.

However, much of the business of the manor court is common to most. The transfer of land from one tenant to another, whether by inheritance or by purchase, (even in the 14th century there are examples of the creation of family trusts), regulation of the open fields (if they exist), the pasturing of animals and the prevention of stray animals are all routine topics. Commercial arrangements between tenants and the disputes that these brought about are also commonplace. However, this routine business can itself record climactic events, for example the rolls for Horton and Alrewas for 1349 record the deaths of tenants due to the Black Death. The court rolls of the Manor of Longton in the Bishop of Lichfield's estates reveal jurisdiction for *view of frankpledge* (see above) far wider than the manor's normal jurisdiction, extending as far away as Harborne and Tipton. Although episcopal manors like Brewood and Eccleshall were completely independent jurisdictionally of the Manor of Longdon, this extensive *view of frankpledge* does suggest that the Manor of Longdon was in some sense regarded as the administrative centre of the bishop's estate.

Large parchment court rolls are awkward documents to use and the variety of information in them made it difficult for later manorial administrators to identify quickly particular entries that they may have needed to find. Eventually the parchment rolls were seen as redundant but the need for rough notes, draft minutes and so on persisted. It should also be borne in mind that the title at the head of individual court rolls or on the cover of court books does not necessarily reflect the content of the roll or book.

During the 18th and 19th century the business of manor courts in some manors declined and faded. In others there was a new lease of life. The removal of all or nearly all of the tenanted land from the jurisdiction of the manor court to other forms of tenancy, combined with enclosure in the open fields, might mean there was insufficient business remaining to justify the calling of manor courts. In other manors the manorial framework was maintained far more strongly. This was particularly so in places where the existence of an unenclosed waste coincided with the growth of cottage developments dwelling on the waste and also where there were leases of mineral rights underneath the waste, such as Stowheath Manor between Wolverhampton and Bilston. In 1922, the Law of Property Act abolished manorial jurisdiction, but many manors had effectively disappeared long before that date.

Accounts

The accounts record annual income and expenditure, the charge and discharge, paid to and by the manorial steward or bailiff. These cover a single year, usually Michaelmas (29th September) to Michaelmas. The purpose of manorial accounts is not primarily to ascertain profit but to determine whether the accountant has discharged his duty. The income might be from rents, from fines issued in the manorial court or from the sale of produce. The expenditure would include payments for labour, repairs of buildings and the purchase of agricultural material, crops and livestock. Frequently entries are not of money but records of corn sown and harvested, details of livestock and the names of tenants, descriptions of their property and the conditions of their tenancy.
